- Solomon presented the Solid Waste Director's report. He noted that Class D inmate labor has been C-2 suspended as a result of the COVID 19 virus containment efforts.
- Solomon presented the Clean Community report. He noted that Long's efforts and that of other C-3 County employees has been directed to extra cleaning of County public facilities as a result of virus containment.

D: **Old Business:**

- D-1 Cheryl Rose updated the Board on the progress of the safety program. (presented early in the meeting)
- Chairman Newton presented the status of the County's issue in disposing of large animal carcasses. D-2 The county's previous contractor providing disposal services has gone out of business. New bids have come in about 3 time higher than the previous contract. The county has asked for the 109 District's assistance in dealing with carcass disposal. The subject was discussed at length. Carcass disposal is not an element of the Taxing District's mission. The District does not own enough available land to accomplish animal composting. The District does, however, have chipped wood that can be used by any agency or other entity that might accept the task of composting large animal carcasses.
- D-3 Solomon presented agreement for vendor to implement a 109 District web site. Magan made a motion, seconded by Harover that we proceed with the agreement. The motion carried.
