# Shelby County 109 Taxing District Minutes Regular Meeting May 14, 2021

Attendance: Chairman Rusty Newton, Wayne Karem, Kerry Magan, Derek Gould Chairman Newton called the meeting to order at 8:30 a.m.

### A: Administrative Items:

- A-1 Minutes of the April 9, 2021 regular meeting were presented. Motion to approve the minutes was made by Karem, seconded by Magan and approved.
- A-2 Financial Report for April 2021 was presented. Motion to approve the financial report was made by Magan, seconded by Karem and approved.
- A-3 Gould presented a recommendation for transfer of funds from "Reserve for Transfer (\$6,200.00)" to "Tire Disposal (\$5,000.00)"; "Postage (\$200.00)"; and "Director Fees (\$1,000.00)". Magan made a motion to approve said transfer of funds. Karem seconded the motion and the motion carried.

- A-6 Minutes of the April 15, 2021 Special Called Meeting for Budget Approval were presented. Motion to approve the minutes was made by Karem, seconded by Magan and approved.

- B-1 Discussion was held regarding the hiring of a person to fill the position of "Recycling Coordinator I". Only one application was received. Gould will check references and make a recommendation, potentially at a special called meeting provided that no other valid applications are received in the interim.
- B-2 Discussion was held regarding the maturity of the current CD's. Magan made a motion, seconded by Karem that the existing CD's be renewed at a rate of 0.4%. The motion carried.
- B-3 Discussion was held regarding the bonding of 109 Taxing District board members. The issue was tabled due to the need for further investigation regarding the need and amount of required bonds.
